ELIGIBILITY

WEATHER

Events proceed rain or shine. In the event of rain, Secret Supper will arrange for shelter for the table. Absent evacuation type proceedings, under no circumstances will a Participant be entitled to a refund or additional financial accommodations due to poor weather conditions.

REFUNDS AND CANCELLATION POLICY

Due to the nature of the events, no refunds or credits will be given for cancellations. However, if you cannot attend the dinner, you are welcome to transfer your tickets to someone else. Please contact us with the new guest's information at least 48 hours prior to the event or tell the guests using your reservation to give your name at arrival. Transfer of funds for your tickets is your responsibility.
